Already handling a wide range of subjects such as cybersecurity, AI, blockchain security, misinformation or CIP European directives, it is only supposed to widen its perspective to cover as much subject useful to the understanding of CIP/CIR as possible.

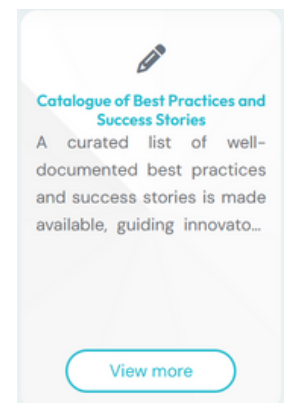
Supporting Innovation and Success

Empowering Stakeholders with a FAIR Observatory

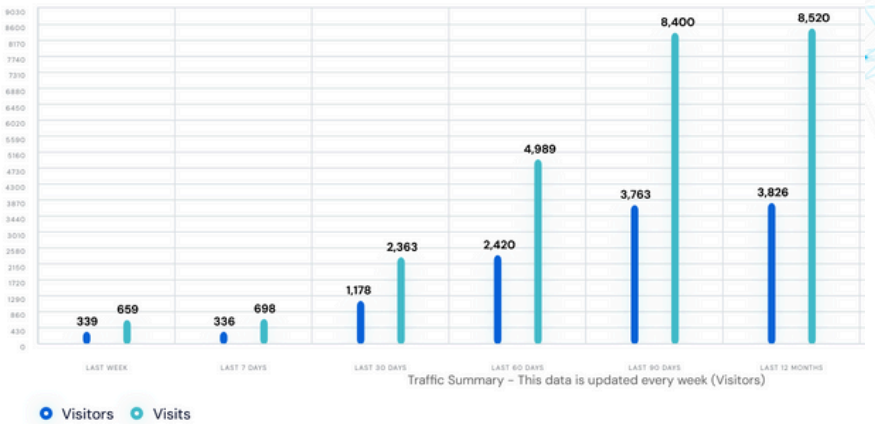

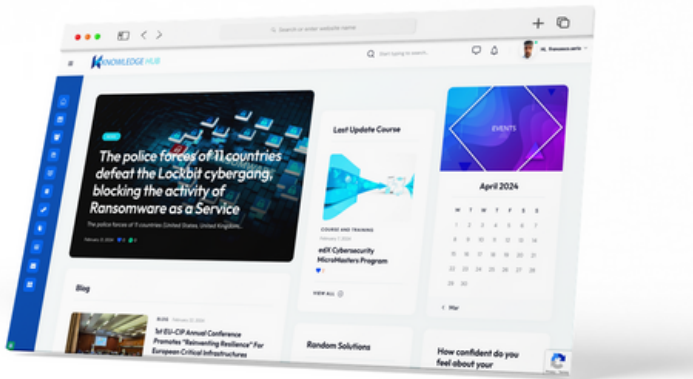
